

Logista Parcel is working intensively to reduce its emissions, achieving a **cumulative reduction of 15% between 2019 and 2022**, in alignment with Logista's decarbonisation plan.

- ESG contracting criteria.





# Environmental Performance

Logista Parcel has developed the **Customer Carbon Footprint KPI Tool**, a powerful tool based on Business Intelligence, to communicate the **Carbon Footprint associated with shipments** to all of its customers. Using this, they can track their relative emissions month by month, by destination, consignee, etc., and in graph format.



## This tool can be used by our clients in:

- Sustainability Reports.
- Results Reports.
- Non-Financial Reporting under Law 11/2018 for large companies.
- Internal and external communications.
- Environmental and carbon footprint audits.





The energy consumption has increased in both warehouses, partly due to an increase in demand for office air-conditioning (in 2021 presence in the facilities was not 100% due to COVID-19).

# Decarbonisation Plan



**The objective set** for the year 2023/24 is to carry out **52%** of our kilometres in ECO or Euro 6 vehicles.

**We have achieved our goal one year early!**  
In 2023 Logista Parcel has more efficient vehicles that pollute less in its fleet.



A Low-emission kilometre is one travelled by more efficient vehicles, including zero-emission vehicles, vehicles that run on alternative fuels or are classified as having lower emissions.

Our vehicles have different stickers to demonstrate this:

- Green C label
- ECO label
- Euro 6 label

\* More than 97% of this data has been verified using the appropriate documentation.

## Measures Planned

- Route optimisation.
- Renewal of the fleet of high-emission vehicles (diesel or petrol) for low-emission vehicles.
- Inclusion of electric or zero-emission vehicles.
- Promotion of intermodal transport.
- Implementation of a new method to improve the calculation and monitoring of emissions from transport services.
- Electricity from 100% renewable sources.
- Promotion of energy efficiency in installations.
- Photovoltaic energy projects for self-supply in the main warehouses.
